Sir Keith Burnett, Vice-Chancellor, University of Sheffield

Professor Sir Keith Burnett became Vice-Chancellor of the University of Sheffield on 1 October 2007. He is an eminent scientist with an outstanding leadership track record.

He was awarded a knighthood in the 2013 New Year's honours list for services to science and higher education. He received a CBE for contributions to the scientific community in 2004 and was elected a Fellow of the Royal Society in 2001.

Lord Bilimoria will reflect on the current political narrative surrounding visas, net migration targets, access to work, skills and talent and how any of these policies might develop in the future. Where next for the UK's international student strategy?

Lord Bilimoria became the President of UKCISA in 2015. He is the founder of Cobra Beer, Chairman of the Cobra Beer Partnership Limited and of Molson Coors Cobra India. He is the Founding Chairman of the UK India Business Council. In 2014, he was appointed as the 7th Chancellor of the University of Birmingham and was the first Indian born Chancellor of a Russell Group University in Great Britain. In 2006, Karan Bilimoria was appointed the Lord Bilimoria of Chelsea, making him the first ever Zoroastrian Parsi to sit in the House of Lords.

Paul Blomfield, MP for Sheffield Central

Paul Blomfield will reflect on the current political narrative surrounding visas, net migration targets, access to work, skills and talent and how any of these policies might develop in the future. From economic benefit to soft power, international competitiveness to responding to the refugee crisis – not to mention of course the EU Referendum which will have taken place only a few days before. Where next for the UK's international student strategy

Paul Blomfield was elected as the Member of Parliament for Sheffield Central in May 2010. He is Secretary of the All-Party Parliamentary Universities Group and a member of the Business Innovation and Skills Select Committee. Paul also set up and chairs the All-Party Parliamentary Group on Students. He was voted Most Inspiring Leader in Higher Education in the Guardian's 2015 University Awards.

Paul worked at the University of Sheffield for over 25 years and prior to his election was General Manager of the Students Union. He has also served as a Governor at Sheffield Hallam University. Since being elected he has been very active on higher education issues - leading against restrictions on international students, opposing the growth of 'for profit' providers and arguing for a better student funding system. Paul has the largest number of students in his constituency of any MP in the country (over 36,000).

Paul is also the Private Personal Secretary (PPS) to Hilary Benn, Shadow Foreign Secretary, and Chair of the All-Party Parliamentary Group on Migration.

Gradlink UK: an introduction to UWE Bristol's award-winning careers site for international students across the UK Discovery Room 1

GradLink (www.gradlinkUK.com) was winner of the Times Higher Award 2015 for 'Outstanding international Student Strategy'. In just over two years, the website has received 200,000 visitors, and students from over 100 UK universities have used it to build and submit their CVs. GradLink has a global network of 350 employers. This presentation will explain how international students across the UK can benefit from the site, and how institutional staff can use it in their work. It will also look at how GradLink has helped UWE Bristol to successfully engage with employers overseas, and how it is enhancing our global reputation.

**Short-term study visa route, pros and cons
Inox Conference Suite 2**

The ELTC (English Language Teaching Centre) has large number of international students who wish to enter the UK, applying for Short-Term study visas (STS) instead of Tier 4 (general). This is mainly their choice or preference. We had to prepare relevant guidelines and documents for staff who are dealing with incoming queries from applicants on the pros and cons of STS. From an institution's point of view, STS is easier as it is not under the PBS so no reporting is required. Azadeh presented this at the recent English UK Management Conference about University of Sheffield's approach to STS.

Improving internationalisation in UK colleges through partnership with overseas institutions

Whilst Universities in the UK have been widely involved in international matters for decades, UK colleges haven't focused significant resources into internationalisation. Newcastle College has been focusing efforts on partnerships with HE institutions abroad and they have contributed significantly to internationalisation of the institution; not only in terms of international student recruitment. Lessons can be learned by other colleges or universities. A study case with a Brazilian institution will be the focus of the session in order to provide the partnership positive outcomes including student experience and staff engagement.

In response to pressure from our Executive to reduce our overall visa refusal rate and to ensure we passed the Basic Compliance Assessment, the Immigration and International Student Advice team took action to implement a new process prior to issuing a CAS. With a team that is responsible for both compliance and student advice, we were conscious of how such a process would affect the student experience. This session aims to examine what we did and how, the impact it had on both our students and staff members, and the viability of continuing the process in the future.

Right first time: embedding the visa application process into the academic curriculum for pre-sessional students

The aim of the session is to showcase how Northumbria University have successfully embedded visa renewal advice within the academic curriculum for pre-sessional students, through close collaboration between academic and support services. We will showcase the 6-week programme of immigration session, how a documents checking service works and how the visa appointments are set up. This may enable the audience to see if they could implement similar processes within their existing visa renewal process for pre-sessional students. This showcase could benefit anyone who plays an active part in renewing large numbers of Tier 4 visa applications from pre-sessional students.

Early warning signals: a university's approach to identifying and supporting vulnerable international students who are 'at risk'

- Duty of care - how far do the University's responsibilities go?
- Providing flexible support within a framework of legal and legislative constraints imposed by external bodies
- How to help when a student doesn't want to be helped - cultural attitudes to illness and mental health

A compliant approach to accepting non-SELT English language qualifications for university entry at degree-level and above **Inox Conference Suite 3**

In response to the reduced availability of Secure English Language Tests (SELTs), universities increasingly need to justify their rationales for accepting alternative qualifications for applicants for study at degree level or above.

This session will provide information from two institutions about their approaches to reviewing their use of HEI discretion to assess English language competence. The sharing of institutional responses to Tier 4 policy changes is at the heart of the Immigration Compliance Network (ICN) for institutional staff working in Tier 4 compliance. Helping international students or corroding learning? A critique of internationalisation at home **View Room 6**

The aim of this session is to debate the purpose and benefits of internationalisation at home (IAH). The leading questions of the session include: ‘Who is IAH for?’, ‘Who benefits from it?’ and ‘whether IAH can corrode learning?’ (could it actually lead to international student disengagement?) The discussion will draw on the presenter’s research into the extent to which backgrounds of international students and profiles of their universities create individualised or common experiences in higher education. The session will present suggestions and practical implications for staff working to support international students.




Room location plans

Room location plans


